- 9. To discuss ways to mark the twenty years of service by former Parish Councillor Robert Jenner.
- 10. To consider any matters relating to the new cemetery including a new noticeboard.

To consider a recommendation from the Amenities & Properties Committee about granting permission for Yatton & Cleeve United Football Club to apply for a 'club' license to sell alcohol to players and supporters during and after matches on Saturdays during the football season. To form a working group to consider all aspects of the licensing and conditions of hire and all other associated matters.
